Seven OceanS Emergency Food Ration is compressed food tablets of each approx. 27.8 g.

Each unit of (500 g net) contains 18 tablets packed in 9 bars with grease-proof paper. The 9 bars are packed under vacuum in air- and watertight alu-foil. This unit is protected by a water-repellent cardboard box.
